I am directed to state that the Board of Governors at its meeting held on 23.04.2019 considered the Compliance submitted by the college authorities vide letter dated 25.02.2019 along with the previous assessment report May, 2018 on the standard of examination and other teaching facilities for Renewal of recognition of MS(Orthopaedics) qualification 02 seats at Pramukhswami Medical College, Karmsad granted by Sardar Patel University, Gujarat and Committee decided as under:-

"The Board of Governors considered the Compliance submitted by the college authorities vide letter dated 25.02.2019 along with the previous assessment report May, 2018 together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MS(Orthopaedics) qualification 02 seats granted by Sardar Patel University, Gujarat in respect of students being trained at Pramukhswami Medical College, Karmsad be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
